## TENDER NOTICE

The Principal Commissioner of Customs, Custom Commissionerate Mundra on behalf of the President of India, invites sealed quotation from interested parties for supply of Tamper Proof Bottle Seals described as below. The Sealed quotations should be addressed to the Joint Commissioner of Customs (P&V), Custom House Mundra.

## Terms and Conditions:

- 1. The sealed tender bids should reach the Joint Commissioner (P&V), Custom House Mundra having office at 5B, Port User Building, Custom House Mundra.
- 2. The tenderer should provide information in respect of their PAN, VAT/TIN No. etc, with the tender and shall submit a signed copy thereof.
- 3. Each Bottle Seal should bear laser engraved running Serial No. & marking as "Mundra Customs" on both parts of the Bottle Seal (Male & Female) and National Emblem (Ashok Stambh) at the head of the Bolttle Seal (Male Part). The name or any other identification of the supplier/manufacturer should not contain on any part of the Bottle Seal. The running serial number will be intimated to the supplier at the time of placing order.
- 4. Technical characteristic required as under:
  - a. Material:
    - Bolt: M.S. (Size-8mm Diameter), Head-18-20mm (without coating) & 20-22mm with coating, Length 78-80mm with coating.
    - ii. Body: Virgin Plastic.
    - iii. Spring: Steel.
    - iv. Coating: Plastic (HIP)- High Intensity Plastic.
  - b. Tensile strength: 1000 to 1200 Kgs.
  - c. Numbering: Directly laser engraved 6 digits.

- d. Colour: White.
- e. Name/Logo: Directly laser engraved in standard font.
- 5. The tenderer should enclose one sample bottle seal alongwith test report reg. the tender having technical characteristic specified at Sr. No. 4 above. The department reserves the right to reject the bid if the sample do not satisfy the technical characteristic as specified above.
- 6. The tender should be signed and stamped by the authorized person and should be complete in all manner. Incomplete tenders will not be entertained and are liable to be rejected.
- 7. The Tender Bids will have a validity of 120 days from the date of opening or as per the discretion of this office.
- 8. The validity of quoted price should be at least for two years from the date of opening tender. Purchase Order will be made on Quarterly Basis. The delivery period would be 15 days from the date of issuance of supply order. For any delay in the supply of goods by the specific date, a liquidated damage of 0.5% of the delivered price of the delayed goods for each week or part thereof subject to maximum limit of 10% of the delivered price of the delayed goods, will be charged for the number of weeks or part thereof of the goods supplied after the specified date given in the supply order.
- 9. The tender should be inclusive of all taxes, packing & forwarding, transportation, freight, insurance, loading & unloading charges, Octroi etc. Octroi Exemption Certificate, if required, will be issued. Rate must be shown in figures as well as in words. No payment over and above the prices quoted shall be made by this office in respect of any such levies brought to the notice at a later date.
- 10. The delivery shall be in 100 Nos. Bottle Seals per Box. The delivery should be made at 5B, Port User Building, Custom House Mundra, Mundra Port, Mundra, Dist. Kutch, Gujarat-370421.
- 11. Defective/unfit/unsuitable/illegible marking of Sr. No. of Bottle Seals, if found at the time of use, new Bottle Seal of the running serial number will be provided free of cost by the supplier. If found that there are repeated complaints of defective supply of Bottle Seals, the department reserves the right to cancel the order or contract anytime during the tenure.
- 12. Specification /Full particulars of Bottle Seals should also be furnished.
- 13. Quantity of Bottle Seals is tentative. The department reserves the right to increase or decrease the actual quantity required at any time without assigning any reason. Payment against bill/invoice shall be released only after delivery and satisfaction of quality of the supplied goods.

- 14. The supplier has to furnish Quality Assurance Certificate alongwith the quotation. Tenderer should furnish documentary proof that they are having good track record of supplying these items to Department and having past experience of dealing in these items for at least for the last three years.
- 15. Sealed tenders should be addressed to the Joint Commissioner of Customs (P&V) having office at 5B, Port User Building, Custom House Mundra and marked as "Quotation for Supply Tamper Proof Bottle Seals" and should reach within 21 days from the date of issue of this notice. The last date of receiving the sealed tenders is 12.01.2017 at 05.00 P.M. Tenders received after the prescribed time limit will not be entertained. Sealed tenders that are incomplete and not addressed to proper authority shall be rejected.
- 16. The issuing authority reserves the right to cancel, postpone, accept or reject any tender without assigning any reason. The decision of the issuing authority will be final.
