Subject: Procedure for DPD clients filing warehouse Bills of Entry and taking delivery of goods from Terminals to Bonded Warehouse without going to CFS- reg

Attention of the Importers, Exporters, General Trade, Port Terminal Operators, Shipping Lines / Shipping Agents, CFSs coming under the jurisdiction of Mundra Commissionerate and all other stakeholders including all PGAs and Customs Bonded Warehouses is invited to P. N. No. 05/2016-17 dated 01.08.2016.

2. Based on the issue raised in various meetings held with various stakeholders and trade representatives, the procedure for clearance of goods from Port Terminals to Customs Bonded Warehouses without going through CFSs in respect of DPD clients is prescribed as under:

- o The importer having DPD facility shall file Advance Warehouse Bill of Entry.
- o Importer shall obtain space certificate from the Customs Bonded Warehouse where he/they desire to warehouse his/their goods after clearance from Port Terminals.
- o The importer shall complete Bond formalities/procedures in Bond Section of Mundra Commissionerate.
- o The importer shall obtain Out of Charge and forwarding of the into Bond Bill of Entry from Superintendent, Dock Preventive.
- o The importer shall take delivery of goods from Port Terminal through transport arranged by self/CFS/Port Terminal/Warehouse etc. and deposit the goods in the concerned warehouse. In warehouse, Importer can carry out further procedure for PGA NOCs/MRP labelling and any other similar compliances.
