**Subject: Levy of Customs Documents Fees.**

Attention of all Exporters/ Customs brokers /Shipping Lines/ Custodians and Members of Trade is invited to the Board's Notification No. 36/2017-Customs (N.T.) dated 11<sup>th</sup> April, 2017 wherein in exercise of the powers conferred by clause (a) of sub-section (2) of section 157, read with clause (1) of sub-section (2) of section 158, of the Customs Act, 1962 (52 of 1962), the Central Board of Excise and Customs hereby makes the following regulations further to amend the Levy of Fees (Customs Documents) Regulations, 1970, namely:-
