Circular**Subject: Conducting of Time Release Study 2018 (TRS) at Mundra Custom House- regarding.**

The Custom Brokers, Port Terminal Operators, Container Freight Stations and all other stakeholders coming under the jurisdiction of Mundra Custom House are herein after informed that this office would be conducting a TRS for the purpose of import and Export.

2. TRS 2018 will be conducted as a live sensitization cum learning experience for the Department to achieve National Trade Facilitation Action Plan target of release time of three days for import of sea cargo and two days for export of sea cargo at this Port. All stakeholders are requested to willingly co-operate in this regard. They are requested to make available data to the officers nominated in the matter.

3. TRS 2018 would cover all Bills of Entries filed during the sample period 01-07 July, 2018 on import side and all shipping bills filed during this period on export side. All the shipping bills and all bills of entries including both advance and normal bills of entry (excluding ex-bond of Bills of entries) filed during this period, from 0000 hrs on 1st July, 2018 to 2400 hrs on 7th July 2018 would be covered in study. The end of data collection period will be 2400 hrs of 7th August, 2018.

4. The Custom Broker Association is requested to inform their members that data not in EDI system regarding time release may be made available by their members. A sample report as below on covered bills of entry and shipping bills (where stuffing has taken place in CFS) duly signed, be provided by the members which are covered in the study –
