Attention of all the Importers, Exporters, General Trade, Port Terminal Operators, Shipping Lines / Shipping Agents, Container Freight Stations coming under the jurisdiction of Mundra Custom House, Vessel operators/ Non vessel Operating Common Carriers and all other stakeholders concerned are invited to Public Notice No. 01/2018-19 dated 20.04.2018, regarding installation of Mobile Gamma Radiographic Container Scanning Facility and Drive- through X-Ray Based Container Scanner Facility at Mundra Port.

2. At present, the two Container scanners are working in two shifts to facilitate trade for scanning of selected Import & Export containers. Details are as under:-



Due to demand of trade and to provide container scanning facility during night hours (24X7 basis), 3 shifts program with effect from 01.08.2019 is scheduled for Drive through Container scanning facility as under :-

Sr. No.	Name of the Scanner	Timing of Ist shift	Timing of IInd shift	Timing of IIIrd shift At Fix scanner
1.	Drive Through Container	06:00 to 14:00 hrs (For Import)	14:00 to 22:00 hrs (For Import)	22:00 to 06:00 hrs (For Import & Export)

Accordingly, it is informed that Import as well as Export Containers will be scanned at Drive through Container Scanner (Fix Scanner) during the night shift. Therefore, the scanning facility will now be available round the clock for both Import and Export containers w.e.f. form 01st August 2019
