INSTRUCTIONS

Kind attention of importers, exporters, Custom Brokers, the trade and all other stakeholder is invited to various Public Notices issued by the Principal Commissioner of Customs, Custom House. Mundra wherein procedure regarding export of Factory stuffed and self-sealed containers and Out of Charge (OOC) of imported Cargo covered under RMS facilitated Bill OF Entry has been prescribed from time to time.

- 2. In this regards, due to effect of Corona Virus (COVID-19) and to avoid crowd at one place, , the following instructions are hereby issued till further orders:-
 - (1) Work related to Let export Order (LEO) of export Cargo covered under Shipping bills of Factory stuffed and self-sealed containers, presently attended by the Officers of Export Cell of Docks Examination, and sitting at the Transworld CFS, can now be attended by the D.E. officers posted in CFS's by following Customs Act/Rules/ Prescribed Procedures.
 - (2) Similarly, work related to Out of Charge (OOC) of imported Cargo covered under RMS facilitated Bill OF Entry, presently attended by the Officers of RMS Cell of Docks Examination, can now be attended by the in-charge D.E. officers of respective CFS where Imported Cargo is lying by following Customs Act/Rules/ Prescribed Procedures.
- 3 The above instructions issued on temporary basis and can be withdrawn any time.
- 4. Difficulties faced if any, may be communicated to this office..
- 5. This issues with the approval of the Commissioner, Custom House, Mundra.
