The empanelled Chartered Engineers are required to prepared their report with professional expertise, integrity, fairness and as per the instructions contained in CBIC Circular No. 07/2020-Customs dated 05.02.2020; the provisions of the Customs Act, 1962 in particular Section 14 read with the Valuation Rules of 2007, after thorough examination/verification of goods.

- 4. The importers/Customs Brokers may make use of the services of any of the empanelled Chartered Engineers for the valuation of the goods referred by the Customs Department. The service charges claimed by the Chartered Engineers for the valuation done by them shall be borne by the importers. At the same time, the certificate issued by the empanelled engineers will be advisory in nature and shall not be binding on the department.
- **6.** Wherever necessary, the Commissionerate reserves the right to seek the service of any of the empanelled Chartered Engineers without any favour or prejudice.
- 7. The empanelled Chartered Engineers have to submit yearly self-appraisal report containing full description of the goods examined and the value appraised by them before the Commissioner of Customs, Mundra by the last week of April next year so to assess the performance and to decide as to whether they are fit for continuing to the panel of Chartered Engineers in the next year.
- **8.** This Commissionerate reserves the right to modify or amend or review the panel periodically to ensure continued adherence to the conditions and standards for which they are empanelled. The Commissionerate may suspend services of the Chartered Engineer at any point of time without any notice on a reasonable belief that their performance is not justified as per Customs requirement.
- **9.** This Public Notice will come into force with effect from the date of issue and will remain effective for one year or till constitution of the next panel whichever is later.
- **10.** Difficulties if any may be brought to the notice of this office.
