## Subject: ICES Advisory 27/2020 (SCMTR) dated 05.08.2020 - Automated Generation of Rotation Number based on VCN - reg.

Attention of the Importers, Exporters, Customs Brokers, Shipping Lines/Agents coming under the juridication of Custom House Mundra and all other stakeholders is invited on the above captioned subject and to the ICES Advisory 27/2020 (SCMTR) dated 05.08.2020 issued by the Central Board of Indirect Taxes & Customs, Directorate Gerneral of Systems, New Delhi (copy enclosed).

2. All the eleigible stakeholders are requested to go through the same and follow the procedure provided therein. Further, it is informed that **Mundra Sea Port** is enabled for automatic generation of rotation number w.e.f. 19.08.2020 (Wednesday). The rotation number for EGM is generated in ICES based on the request by the vessel operator.

Hereinafter, the current system for rotation number generation has been discontinued for the **Mundra Sea Port** and replaced with automatic generation directly based on the VCN message received from PCS or any other system designated by the Port/Terminal for all types of vessel i.e. container, bulk etc.

3. Difficulties faced, if any, may be brought to the notice of the undersigned.

Subject: Automated Generation of Rotation Number based on VCN

Electronic communication of Voyage Call Number (VCN) message has already begun for those ports who are already on PCS platform. Once VCN message is filed with Customs, there will be automated generation of Rotation Numbers based on the VCN messages received by customs automated system. The current practice of Shipping Lines applying for rotation number from ICES at the Customs formations accordingly would be discontinued in phased manner.

- Currently, rotation number for EGM is generated in ICES based on the request by the 2. vessel operator. This current system for rotation number generation will be discontinued for seaports and be replaced with automatic generation directly based on the VCN message received from PCS or any other system designated by the Port. A VCN enquiry is already number for check the rotation ICEGATE to (https://enquiry.icegate.gov.in/enquiryatices/vcnEnquiryAction). The Shipping Lines can also directly obtain the same from Port or PCS. The same rotation number should be used for filing EGM and for preparing messages for both, Sea Arrival and Sea Departure Manifests under the SCMTR.
- 3. As you would appreciate, this would require awareness among the shipping Lines operating at your port and readiness of the port system to share (i) VCN message with ICEGATE, (ii) receive the rotation number, and (iii) share the same with the Shipping Lines. For the ports already integrated with PCS, the same would be exchanged between ICEGATE and PCS. A confirmation from shipping lines whether they are sharing VCN details with PCS should be obtained.
- 4. For the other ports not integrated with PCS, web-based utilities have been made available on ICEGATE within the login of terminal operators to submit the VCN details and receive the rotation number. The terminal operatorswill also be able to check the rotation number in the VCN based enquiry on ICEGATE as mentioned at para 2. Such Terminal operators can also integrate with customs automated system. - 4. You are requested to reach out to the Shipping Lines, terminal operators/port authorities in your jurisdiction to ensure their readiness by 10.08.2020, after which the new dispensation for automatic generation of the rotation number will begin port by port. While the VCN message for ports connected with PCS is already being received by Customs, other ports in your jurisdiction may be asked to start submitting the same through the web utility mentioned in para 3.
- 5. Once a port is enabled for automatic generation of rotation number, rotation number would be available only against the VCN details submitted by the port/terminal. The exercise is targeted for completion for all major seaports by 15.08.2020.
